# ALBAUGH LICTIS 800 EC HERBICIDE

## STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple-rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

## Returnable containers

Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

## SAFETY DIRECTIONS

Will irritate the eyes and skin. Repeated exposure may cause allergic disorders. Sensitive workers should use protective clothing. Avoid contact with eyes and skin. When opening the container and preparing product and using the product, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing) and elbow-length chemical resistant gloves and face shield or goggles. In addition, when opening the container and mixing and loading, wear disposable mist face mask covering mouth and nose. If product on skin, immediately wash area with soap and water. If product in eyes, wash it

out immediately with water. Wash hands after use. After each day's use, wash gloves and face shield or goggles and contaminated clothing.
