### GENERAL INFORMATION

**Foam Marker Select** is a high visibility, stable foam marker engineered to remain tough and flexible under a wide variety of field conditions whether the water source is hard, soft, hot or cold. **Foam Marker Select** enables the applicator to spray accurately without the skips, gaps and overlaps that can lead to reduced pesticide effectiveness.

### DIRECTIONS FOR USE

For best results, begin with a freshly cleaned foam tank. Foam generation can be affected by scale, rust or other solid materials in the tank. Mix **Foam Marker Select** with water and place in foam marker tank.

Use 1 gallon of **Foam Marker Select** for every 100 gallons of water.

**Foam Marker Select** is formulated to be a 100:1 foam marker. Over dosing and under dosing can lead to poor quality foam, but the rate may be carefully adjusted. If foam is runny or watery, add additional **Foam Marker Select** until preferred texture and stability are attained. If foam is too thick, add water.

### STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product. Shake well before using. If product freezes, allow to thaw, then shake well. For optimal storage, store between 40° and 90° F.

**Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
